The Distribution Rate is calculated in accordance with the Note Terms as 70% of the aggregate of the Bank Bill Rate (refer 3D.6) and the Margin (refer 3D.8) (together the "Aggregate Rate"). The figure in 3D.10 represents 30% of the Aggregate Rate (ie the current corporate tax rate) - this amount is deducted from the Aggregate Rate to calculate the Distribution Rate (refer 3D.12) under the Terms. As such, the adjusted Distribution amount contained in 2A.9 and 3A.1b cannot be directly calculated by reference to the Distribution Rate.
