The figure in 3D.10 represents 30% of the Aggregate Rate (ie the current corporate tax rate) - this amount is deducted from the Aggregate Rate to calculate the Distribution Rate under the Terms. Pursuant to condition 3.2 of the Note Terms, the Distribution amount in 2A.9 and 3A.1b has been adjusted to reflect a Franking Rate of 70%. No non-resident withholding tax is payable on the unfranked component by holders resident outside Australia as the unfranked component of the Distribution will be sourced from ANZ's conduit foreign income account.
