Pillar 3 restatement



ANZ has undertaken the reissue of historical Pillar 3 returns for the disclosure periods 30 September 2019 to 31 March 2024 inclusive.

For each reissued document, ANZ has restated historical values for APRA Level 1 Extended licensed entity Total Risk Weighted Assets and Level 1 Capital Ratios (including the Level 1 CET1 ratio) to reflect the application of the \$500 million Operational Risk capital overlay to both our Level 1 and Level 2 entities. No Level 2 values have been affected. Note that these changes were already incorporated in the June 2024 Pillar 3 disclosure.
